Grantor agrees that all poles, wires and other facilities, including any main service entrance equipment, installed on the above-described lands at the Grantee's expense shall remain the property of the City of Lexington, removable at the option of the City of Lexington, upon termination of service to or on said lands.

Grantor further covenants that it is the owner of the above-described lands.
