**RESOLUTION TO RECOGNIZE REVENUE AND APPROPRIATE EXPENDITURES
IN THE AMOUNT OF \$10,000 FROM EL PASO COUNTY PUBLIC HEALTH TO THE
2020 COMMUNITY SERVICES BUDGET TO SUPPORT A CRIMINAL JUSTICE AND
BEHAVIORAL HEALTH GAPS AND NEEDS ANALYSIS**

WHEREAS, the Criminal Justice Coordinating Council and El Paso County were awarded a \$60,000 Colorado Springs Health Foundation capacity-building grant that was recognized through Resolution No. 20-47 on January 30, 2020 for a Criminal Justice and Behavioral Health Gaps and Needs Analysis; and

WHEREAS, El Paso County Public Health agreed to provide \$10,000 to support the local match for the grant; and

WHEREAS, this Analysis supports the El Paso County 2017-2021 Strategic Plan Goal #5 - Strategy A: Support a high level of public safety to include law enforcement, justice services and prosecution, and Objective 6: Seek new and support existing innovative programs which intend to reduce recidivism and length of stay in the El Paso County Jail; and

WHEREAS, the project budget is derived from \$60,000 from the CSHF Capacity-Building grant, and \$40,000 in local matched funds (\$10,000 from the 4th Judicial District Useful Public Service, \$7,000 from El Paso County, \$10,000 from El Paso County Public Health, \$10,000 from the Pretrial Services Community Advisory Board, and \$1,000 each from Penrose-St. Francis Health Services, Springs Rescue Mission, and UC Health Memorial Hospital) for a total project budget of \$100,000.

NOW, THEREFORE, BE IT RESOLVED, the Board of County Commissioners of El Paso County does hereby recognize revenue and appropriate expenditures in the amount of \$10,000 from El Paso County Public Health in the following manner:
