**RESOLUTION TO RECOGNIZE FEDERAL REVENUE AND APPROPRIATE
EXPENDITURES IN THE AMOUNT OF \$296,656 TO THE ROAD AND BRIDGE
2020 BUDGET FOR CONSTRUCTION OF ELBERT ROAD BRIDGE
REHABILITATION PROJECT**

WHEREAS, on July 24, 2018, El Paso County (hereinafter EPC) entered into a contract so designated as Project BRO C040-040; 20603 (Resolution 18-296, Reception No. 218085267) with the Colorado Department of Transportation (hereinafter CDOT) for the Elbert Road Bridge Rehabilitation Project; and

WHEREAS, Federal Aid funds (CFDA#20.205) have been made available for the Elbert Road Bridge Rehabilitation Project; and

WHEREAS, the matching funds ratio is 82.79% (\$296,656) federal aid funds and 17.21% (\$61,668) local agency funds; and

WHEREAS, these funds support the El Paso County Strategic Plan's Goal #3 - Maintain and improve the County transportation system, facilities, infrastructure and technology.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of El Paso County, Colorado, does hereby recognize revenue in the amount of \$296,656 in federal reimbursements, and appropriates expenditures in the amount of \$296,656 to be combined with the total \$61,668 local match in the following manner:
