WHEREAS, the City of Colorado Springs, a home rule city and Colorado municipal corporation, by and through the Colorado Springs Fire Department ("CSFD") is in possession of used firefighting equipment and gear that it wishes to donate to El Paso County, which includes the following: 1997 Type 1 Fire Engine, identified as Vehicle Identification No. 44KFT4284TWZ18101; and

WHEREAS, El Paso County acknowledges that this donated equipment is in "used condition and may no longer conform to express or implied warranties" as further delineated in the Used Firefighting Gear and Equipment Donation Agreement, attached hereto as Exhibit 1: and

WHEREAS, the Board believes it will serve the public welfare and best interests of the citizens of El Paso County to accept the donation from the City of Colorado Springs and enter into the Used Firefighting Gear and Equipment Donation Agreement.

NOW THEREFORE, BE IT RESOLVED that the Board of County Commissioners of El Paso County, Colorado, hereby authorizes and approves the Used Firefighting Gear and Equipment Donation Agreement and accepts the donation of used firefighting gear and equipment from the City of Colorado Springs as herein stated.

Used Firefighting Gear and Equipment Donation Agreement

This Agreement is entered into between the City of Colorado Springs ("City"), a home rule city

and Colorado municipal corporation, by and through its Colorado Springs Fire Department

("CSFD") and El Paso County, Colorado ("El Paso County"). The purpose of this Agreement is

to facilitate the donation of used firefighting gear and equipment from the CSFD to El Paso

County.

El Paso County acknowledges that donated gear and equipment is in used condition and may no

longer conform to express or implied warranties provided by the original manufacturer. El Paso

County specifically agrees that the City, CSFD, and individual employees and agents of the City

provide no warranty regarding usefulness, safety, or currency of the gear and equipment. El Paso

County expressly releases and agrees to hold harmless the City, its officers, agents, and employees,

for any liability or claim arising in connection with the use of the donated firefighting gear and

equipment.

El Paso County agrees to inform all its employees, volunteers, or agents using the donated

firefighting gear and equipment of the age and used condition of the donated firefighting gear and

equipment. El Paso County must ensure that those using the donated gear and equipment warrant

that they understand the age and condition of the donated firefighting gear and equipment and

acknowledge the risks associated with its use.
