RESOLUTION TO GRANT A QUITCLAIM DEED FROM EL PASO COUNTY TO THE CITY OF MANITOU SPRINGS, COLORADO, ASSOCIATED WITH THE WEST COLORADO AVENUE PROJECT

WHEREAS, pursuant to C.R.S. §§ 30-11-101(1)(c), 30-11-102, and 30-11-103, the Board of County Commissioners of El Paso County, Colorado (hereinafter "Board" or "County") has the authority to sell, convey, or exchange any real property owned by the County and make such order concerning the same and to exercise such other and further powers as are conferred by law; and

WHEREAS, the County partnered with various entities to construct a Pikes Peak Rural Transportation Authority — approved project known as the West Colorado Avenue road construction project ("project"); and

WHEREAS, portions of the project were completed on right-of-way owned by El Paso County but located in or adjacent to the City of Manitou Springs; and

WHEREAS, since the project is now completed, it is appropriate to convey said right-of-way to the City of Manitou Springs by way of a Quitclaim Deed to permit ongoing maintenance of the roadway; and

WHEREAS, the Board has determined that it would serve the best interests of the public to grant the Ouitclaim Deed attached hereto as Exhibit 1 to effectuate the above-described transaction.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners hereby grants the attached Quitclaim Deed to the City of Manitou Springs subject to the terms and conditions cited therein.









EXHIBIT "A"

LEGAL DESCRIPTION
