This item is to request approval of Awards of El Paso County Trade Contractor Agreements for Bridges Maintenance and Repair Work up to \$1,000,000.00 for the Department of Public Works Department - Engineering Division (SOQ 25-014).

BACKGROUND (including information on budgeted matters)

A Statement of Qualifications (SOQ) was advertised on January 22, 2025, for Bridge Maintenance and Repair up to \$1,000,000.00. Responses were received on February 19, 2025, and after a thorough evaluation process eight (8) contractors, WW Clyde & Co., ABCO Contracting Inc., Wildcat Construction Co. Inc, West Fork Construction LLC, Structures Inc., Schanel Construction Inc., Myers and Sons Construction LLC, and Ability Design Build LLC, were selected for on-call bridges maintenance and repairs. All of the contractors are qualified to complete bridge maintenance and repairs.

The SOQ was advertised to qualify experienced contractors to award multiple task orders for bridge maintenance and repairs for the County. The Department of Public Works – Engineering Division will issue task orders to the eight selected contractors as the need arises. If a project is anticipated to exceed \$1,000,000.00, the County will follow the current procedure and regulations and provide for competition of the project through a formal and open competitive solicitation process.

Wildcat Construction Co., West Fork Construction, LLC, Schanel Construction, Inc, and Ability Design Build, LLC are located in Colorado Springs, Colorado. WW Clyde and Co. and Structures, Inc. are located in Englewood, CO. ABCO Contracting, Inc. is located in Denver, CO. Myers and Sons Construction, LLC is located in Sacramento, CA.
